For the IEA Elections 2017,NOMINATIONS in prescribed form are invited from members for the following posts:

- Conference President of 101st Annual Conference—To be elected, if need be, from among the name/s proposed by the EC (for a term of 1 year from April 2018—March 2019)
- President (Association) —To be elected, if need be, from among the name/s proposed by the EC (for a term of 2 years from April 2018—March 2020)*
- State Representatives as Executive Committee Members of following 5 states (for a term of 3 years from April 2018—March 2021):

TapanShandilya, only for a period of 1 year, the present election would only be for the remaining 2 years of the usual 3 year term.

Note:Completed Nomination papers, duly filled in and signed, along with a brief Bio-data/CV of the candidate, should be sent either by email or by post to the Election Officer latest by **30th September 2017**. Incomplete nomination forms or with additional insertions /elements like photographs, overwriting etc. or not accompanied with a brief Bio-data/CV of the candidate, shall be cancelled. The last date of withdrawal is **October 31, 2017**.

Special Note: Since Thoratji had rejected the resignation letter submitted by Prof. Thakurji and asked Prof. Thakurji to continue as General Secretary and Treasurer of IEA for Full Term till March, 2019. Hence, there is no Election for the Office of General Secretary and Treasurer of IEA. I have reproduced the Letter Written by Prof. Thorat Sir here for the kind information of IEA Members.

I had sent you the email in which I have not accepted the resignation of Anil Thakur from the post of General Secretary and Treasurer. Kindly see my email of May 22 .below. Despite this, I see that there is notification for the post General Secretary and Treasurer in election Notification on IEA website. I have already rejected the resignation of Anil Thakur from the post of General Secretary and Treasurer. Therefore I suggest that this portion of notification be removed from the website. I hope you will do it soon .and inform me.
